In consideration of being permitted to participate voluntarily in the 2011 Lake Powell Challenge Poker Run event ("Event"), the undersigned for myself, my heirs, executors, administrators, and assigns accepts full responsibility for and risk of bodily injury, death or property damage and does hereby release and agree to indemnify and hold harmless Antelope Point Holdings, LLC ("APH"), their affiliates, sponsors, organizers, committee officials and each of their respective servants, agents or employees from any claims, demands, damages, actions or causes of action arising out of or in consequence of any loss, injury, or damage to my person or property incurred from any cause whatsoever, in consequence of attendance or participation in the Event notwithstanding that any such loss of injury or damage may have arisen by the reason of, including but not limited to, the negligence of APH, their sponsors, organizers, affiliates, and committee officials or any of their respective servants, agents or employees. The undersigned further agrees to hold the said APH, their sponsors, organizers, affiliates, and committee officials harmless and hereby does indemnify them from any and all liability for personal injury, death, or property damage to third parties which may occur in any manner arising out of my attendance or participation in the Event. The undersigned further acknowledges that the Event is not a race and that speed in no way determines the outcome of the Event, and hereby agrees to abide by any and all rules, directives, terms and conditions of the Event as set forth by the organizers and/or committee officials, either verbally or in writing, before or during the Event. No alcohol in boats while the boat is being operated. Each driver and throttle person agrees that they will not have

consumed alcohol nor taken any illegal substances six (6) hours before this Event and will not consume either while operating the boat. Use of such can and will result in immediate disqualification.

The undersigned further acknowledges that all persons on board 17 years of age and younger must be accompanied by a parent or legal guardian while the boat is being operated. All boats must be equipped with Personal Floatation Devices/Life Jackets and APH encourages all boat occupants to wear such during the Event.

The undersigned had read and voluntarily signs this Waiver and Release of Liability and Indemnity Agreement and further agrees that no oral representation, statements or inducements apart from the foregoing written agreement have been made. The parent or legal guardian of any minor passenger further recognize and agree that they are executing this Waiver and Release of Liability and Indemnity Agreement on behalf of themselves and their minor child(ren).
